Please note = As this is a licenced vehicle, it has the standard 3rd party insurance, all other insurances must be covered in your motor vehicle insurance policy, please make sure your policy covers the towing a trailer as it is not standard.

# Booking Conditions

## Bookings and deposits

Busselton Camping Hire will take a tentative booking over the phone and hold that booking for a period of 48 hours.

A deposit fee is required once the booking has been made and the hirer will be invoiced for the deposit amount. If the deposit has not been paid within the 48 hour period, Busselton Camping Hire reserves the right to cancel the booking.

## Booking Period

The hirer will be charged for all equipment hired on a "Time taken" and not a "Time used" basis. Hire of our Camper trailers and other equipment is for the agreed time only, while every effort is made to accomodate extensions to the initial hire period requested, we can not guarantee that an extension of the rental will be a achieved.

# Hire Conditions

## Insurance

a \$3000.00 excess is payable by the hirer in the event of damage or loss through accident/fire/theft (including water immersion).

Customers should be aware that your vehicle insurance (comprehensive or 3rd party) does not cover the camper trailer in case of any damage or accident.

## Unauthorised use and Reposeession:

Be advised that, Busselton Camping Hire, may take possession of the trailer or other equipment without prior demand and at the hirers expense if it is illegally parked, used in violation of the law or the hire agreement or is apparently abandoned.

The hirer also agrees to, under any circumstances whatsoever, allow Busselton Camping Hire, or any representative nominated by it, to enter the hirers premises, or the premises where the trailer or other hire equipment has been parked, left or abandoned by the hirer or any in the company of the hirer, in order for Busselton Camping hire to reclaim possession of the assets subject to the hire terms agreed to.

## Cleaning charges

Busselton Camping Hire reserves the right to withhold from the bond a cleaning fee if the trailer or equipment is not returned in what Busselton Camping Hire deems to be a suitable condition. This includes, where considered necessary, treatment for appartant strong odours such as cigeratte and tobacco smoke, fish odours etc. the cleaning fee is based on an hourly rate of \$88.00 per hour.

## Repairs and damages

All damages to the equipment while in possession of the hirer must be reported immediately to the management of Busselton Camping Hire.

Repairs to all damages to the camper undertaken whilst in the possession of the hirer shall become the sole responsibility of the hirer to repair to a condition at least equal to the condition of the equipment

prior to the damage or theft event occurring. All repairs are to be undertaken only as authorised by the management of Busselton Camping Hire, using qualified service personnel approved by Busselton Camping Hire. All costs of repairs required shall be paid for by the hirer.

Under no circumstances shall a third party be engaged, or act on behalf of the hirer for the purpose of repairs unless specifically authorised by Busselton Camping Hire.

### Tyre Damage

The Hirer is responsible for the cost and of repairs of any tyre puncture throughout the duration of the hire period.

Should any tyre be returned that requires repair or replacement, the cost of such repairs or replacement, will be at the Hirers expense.

## Hirer's declaration

The Hirer declares that:

a - The Hire Equipment is towed only by the persons listed on the Hire Agreement and hold a current, non restricted Australian drivers licence of the appropriate class, and is over 21 years of age.

The licence must be sighted by the owner at the commencement of the hire period.

b - The Hirer will not modify the equipment in any way, this includes the carrying of other goods on top of the hire equipment.

c - The information provided on the Hire Agreement is correct in every respect and is not misleading in any way.

d - It is the Hirer's obligation to ensure the Hire Equipment is not misused in any way or used for any illegal purposes.

e - The vehicle used for towing the Hire Equipment is registered, roadworthy and suitable for towing.

f - The Hirer is responsible for damage caused to the underneath of the Hire Equipment regardless of cause.

g - The Hirer is responsible for all costs incurred due to damage caused by submersing the Hire Equipment either fully or partially in water

h - The Hirer is responsible for any damage to the interior of the Hire Equipment, regardless of cause.

I - The Hirer is responsible for any damage caused to the overhead of the Hire Equipment. Please be mindful that there is enough clearance from trees and other obstructions before setting up Hire Equipment.
